#### DESCRIPTION AND APPLICATIONS

The Electro-Voice RE1000 is a true condenser studio microphone. It provides flat frequency response, low self-noise and an externally biased transducer. The RE1000 utilizes a transformerless output.

The RE1000 is designed to have the industryleading "rugged and reliable" Electro-Voice durability, while providing excellent performance.

The RE1000 has an internal, two-stage pop filter to reduce explosive breath blasts and wind noise. An extremely effective shock-mount system, for use when excessive mechanical noise is encountered, is available as model 325.

The RE1000 is designed for high-quality recording and sound reinforcement. Wide use of phantom power makes the microphone very flexible. The combination of very low self-noise, excellent transient response and smooth frequency response makes the RE1000 an ideal choice for use in the most demanding of situations.

 Wind Tech<sup>™</sup> is an Olsen Audio Group, Inc., company. The 20/421 windscreen can be purchased separately from Wind Tech<sup>™</sup> at 602/998-7140 or (fax) 602/998-7192. A hard-shell case is included for storage and transport.

A switch on the rear of the unit introduces a 12dB-per-octave low-frequency roll-off at 130 Hz.

The transducer is a short-D, high-efficiency unit, with the high output level of a large diaphragm and the tighter polar pattern and better transient response of a smaller diaphragm. The diaphragm itself is an ultra-thin, gold-laminate, environmentally stabilized, low-mass design. The rear electrode is a gold-laminated, ceramic design, precisely spaced from the diaphragm.

The output electronics provide no voltage gain to ensure the lowest self-noise. The RE1000's high sensitivity is achieved through optimal transducer design.


### ARCHITECTS' AND ENGINEERS' SPECIFICATIONS

The microphone shall be a supercardioid true condenser with a frequency response of 70-18,000 Hz. It shall have an output of not less than 11 mV/pascal at 1 kHz, with self-noise no greater than 14 dBA. The output shall be a balanced, transformerless output. Output termination shall be a professional three-pin XLR-type connector to facilitate connection to the user's equipment. It will be housed in a protective case. The microphone shall be the RE1000.


### UNIFORM LIMITED WARRANTY


On initial powering of the mic, there is a stabilization period of 15 to 20 seconds, during which the output of the microphone will be muted.
