- 2. The promotion period will be, November 13 until November 29 in 2020.
- 3. The promotion is open to private persons only. To enter the promotion as an individual, on behalf of a company under any circumstances is prohibited and will result in disqualification from the promotion.
- 4. A minimum purchase of one unit (1) from the Electro-Voice EVOLVE series during the promotion period defined in paragraph 2 is necessary to enter the promotion.
- 5. To enter the promotion, entrants must register the reference action code "TR11" as well as their details (full name, postal address, country, phone number, e-mail address) via <a href="www.promo-ev.com">www.promo-ev.com</a>. Entrants have to provide details about their purchase (type, quantity, date and country of purchase). A proof of purchase by sending in a scan of the original invoice issued by an official dealer or reseller is mandatory. Without proof no free of charge item of the respective variant can be granted.
