### TERMS AND CONDITIONS FOR ELECTRO-VOICE CASHBACK PROMOTION

1. By entering this promotion, entrants agree to be bound by these Terms and Conditions.
2. The promotion period will be, August 1 until September 30 in 2020.
3. The promotion is open to private persons only. To enter the promotion as an individual, on behalf of a company under any circumstances is prohibited and will result in disqualification from the promotion.
4. A minimum purchase of one unit (1) from the Electro-Voice ZLX-BT range and/or EVOLVE 50 during the promotion period defined in paragraph 2 is necessary to enter the promotion.

To enter the promotion, entrants must register the reference action code “CB20” as well as their details (full name, postal address, country, phone number, e-mail address) via [www.promo-ev.com](http://www.promo-ev.com). Entrants have to provide details about their purchase (type, quantity, date, country of purchase) and provide bank account details to enable us to carry out the bank transfer. A proof of purchase by sending in a scan of the original invoice issued by an official dealer or reseller is mandatory. Without proof no cash back will be granted. The cashback for the proof of purchase will be done via bank transfer.

10. The cashback is applicable to the ZLX-BT loudspeaker range and EVOLVE 50 as defined in paragraph 9 and purchased within the promotion period. Cashback can be claimed up to and including October 31, 2020. The cashback is non-transferable.
11. Bosch reserves the right to change any of these terms at any time or to terminate the promotion early. This applies in particular in the event of force majeure and in the event that proper execution of the promotion cannot be guaranteed for technical or legal reasons
12. The recourse to the courts is excluded.
13. Any tax liability arising from this promotion and/or the cashback is the responsibility of the participant. The cashback will be paid in EUR (or British Pounds for UK) by bank transfer. Any charges or costs imposed by the receiving bank in connection with the bank transfer are born by the participant and no restitution will be done by Bosch. The same applies to any losses due to changes in the currency exchange rate.
14. If required the participant will be contacted by Bosch and/or third parties approved by Bosch after handing in their details and proof of purchase described in paragraph 5. All of the participants information is required, as described above in paragraph 5, in order to process the cashback bank transfer. If any of the participant's information is missing and Bosch and/or third parties approved by Bosch proceed the cashback via bank transfer and therefore cannot execute the cashback, the participant loses their claim for the cashback 1 month after the closing date of the promotion, defined as October 31, 2020 at the latest.
